(**failure to declare a disclosable pecuniary interest is a criminal offence**).

Note – A Member must, within 28 days of becoming aware of any new personal interest or change to any personal interest specified above, register details of that new personal interest or change by completing a new Register of Interest Form and submitting it to the Borough Council's Monitoring Officer.


