The Local Authorities (Disclosable Pecuniary Interests) Regulations 2012

In order to comply with the Parish/ Town Council's Code of Conduct, a Member or Co-opted Member must register their pecuniary and interests other than pecuniary interests with the Parish Council's Monitoring Officer within **28 days** of the date of their election or co-option. ***Failure to declare a disclosable pecuniary interest is a criminal offence.***

Note – a Member must, within 28 days of becoming aware of any new personal interest or change in a personal interest specified above, register details of that new personal interest or change by completing a new Register of Interest Form and submitting it to the Borough Council's Monitoring Officer.
